**A RESOLUTION ACCEPTING THE PLANNING AND ZONING COMMISSION'S APPROVAL OF THE SITE PLAN FOR THE CENTRAL ADMINISTRATION BUILDING ("CAB"), ~~AND DECLARING AN EMERGENCY.~~**

WHEREAS, at its regularly scheduled meeting on June 20, 2007, the City of Green Planning and Zoning Commission conditionally approved the site plan for the CAB by a vote of 4-0; and

WHEREAS, Resolution 2005-R89, which established interim development controls for the Massillon Road corridor, including this property, requires City Council approval of this project.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:**

**SECTION ONE:**

Green City Council, pursuant to Resolution 2005-R89, confirms the site plan for the CAB.

**SECTION TWO:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

**SECTION THREE:**

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
