A RESOLUTION CREATING THE POSITION OF RECREATION ASSISTANT, ESTABLISHING A RATE OF COMPENSATION, AND DECLARING AN EMERGENCY.

WHEREAS, it is necessary to create the position of Recreation Assistant to aid in the services and duties required in the City of Green Parks and Recreation Division; and

WHEREAS, it is necessary to establish a rate of compensation for the position of Recreation Assistant.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:

SECTION ONE:

Green City Council establishes the position of Recreation Assistant.

SECTION TWO:

The position of Recreation Assistant will be added to the listing of bargaining unit jobs at a base rate of \$10.50 per hour an hour and incorporated into the step level pay ranges in a normal manner.

SECTION THREE:

The position of Recreation Assistant is part-time and is an unclassified position under the terms of the Civil Service Rules and Regulations.

SECTION FOUR:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FIVE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
