A RESOLUTION ESTABLISHING PAY RATES FOR PAYMENT OF PART-TIME POSITIONS IN THE CITY OF GREEN FIRE DIVISION AND DECLARING AN EMERGENCY.

WHEREAS, the Mayor, pursuant to his authority in the Charter, has authorized the creation of several part-time positions within the Fire Division;

WHEREAS, the use of part-time employees within the Fire Division will save money and not reduce or interfere with the quality of services provided by the Fire Division;

WHEREAS, the Administration wishes to establish part-time pay rates for the following existing positions: Firefighter/EMT, Fire Safety Inspector, FireMedic, Lieutenant and Captain; and

WHEREAS, it is necessary for City Council to approve a pay rate for payment of individuals who perform part-time services in these positions for the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:

SECTION ONE:

Green City Council approves the following pay rates for part-time positions within the Fire Division:

- Firefighter/EMT \$16.00/hour
- Fire Safety Inspector \$16.00/hour
- FireMedic \$18.00/hour
- Lieutenant \$20.00/hour
- Captain \$22.00/hour

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise, it shall take effect and be in force at the earliest time allowed by law.
