A RESOLUTION AUTHORIZING AN APPROPRIATION TO ALLOW THE CITY TO HIRE A CONTRACTOR FOR THE HARTONG FARMHOUSE AND SUMMER KITCHEN ROOF REPLACEMENT PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, the City solicited bids to replace the roof on the Hartong Farmhouse and Summer Kitchen, located in Southgate Park; and

WHEREAS, the City desires to hire R2K Contracting Inc. to perform the work; and

WHEREAS, the City also desires to make an additional amount of appropriations so they can consider hiring a contractor for four (4) other roof sections on this structure; and

WHEREAS, it is necessary to appropriate funds to hire the contractors for this Project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

City Council authorizes an appropriation of Thirty Thousand Dollars (\$30,000.00) from the unappropriated General Fund from Account No. #100-5110-53632 (Hartong Farmhouse Roof Replacement).

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
