A RESOLUTION CONFIRMING THE SITE PLAN FOR HERITAGE CROSSINGS SMALL SHOP SPACE, AND DECLARING AN EMERGENCY.

WHEREAS, at its regularly scheduled meeting on May 15, 2013, the Planning & Zoning Commission made a recommendation for the site plan of the Heritage Crossings Small Shop Space by a favorable vote of 3-2; and

WHEREAS, Green Codified Ordinance Section 1228.02(1) requires City Council to confirm the final approval of the Planning & Zoning Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council, pursuant to Green's Codified Ordinance Section 1228.02(1), confirms the site plan for Heritage Crossings Small Shop Space.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
