**A RESOLUTION AMENDING THE PAY GRADE LEVEL OF CLERK OF COUNCIL,
AND DECLARING AN EMERGENCY.**

WHEREAS, it is the recommendation of Clemans, Nelson & Associates, Inc. to adjust the pay grade for the Clerk of Council from a Pay Grade Level 6 to a Pay Grade Level 8; and

WHEREAS, Green City Council has reviewed the duties and responsibilities of the Clerk of Council; and

WHEREAS, Green City Council desires to increase the pay grade level for the Clerk of Council position.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

SECTION ONE:

Green City Council approves an increase of the pay grade for the Clerk of Council from Pay Grade Level 6 to Pay Grade Level 8.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:


Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise, it shall take effect and be in force at the earliest time allowed by law.


