A RESOLUTION TO APPROVE THE SOLID WASTE MANAGEMENT PLAN FOR THE SUMMIT AKRON SOLID WASTE MANAGEMENT AUTHORITY, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green is located within the Summit Akron Solid Waste Management Authority ("Authority"); and

WHEREAS, the Summit Akron Solid Waste Management Authority Board of Trustees prepared and adopted a final draft of the Solid Waste Management Plan in accordance with Ohio Revised Code Sections 3734.53, 3734.54 and 3734.55; and

WHEREAS, the Summit Akron Solid Waste Management Authority has provided a copy of the Draft Final Solid Waste Management Plan for ratification to each of the legislative authorities of the District; and

WHEREAS, the City of Green must decide whether it approves the Solid Waste Management Plan within ninety days (90) of receipt of the Final Draft Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT AND STATE OF OHIO, THAT:

SECTION ONE:

The City of Green approves the Summit Akron Solid Waste Management Plan.

SECTION TWO:

City Council directs the Clerk to send the Authority a certified copy of this Resolution to the attention of Yolanda Walker, Executive Director, Summit Akron Solid Waste Management Authority, 12 East Exchange Street, 3rd Floor, Akron, Ohio 44308.

SECTION THREE:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting of this Council and any deliberations of this City and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION FOUR:

~~Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Council declares these corrections to be made immediately so that the corrections can be finalized and circulated to the~~

Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.~~
