A RESOLUTION AUTHORIZING THE CITY OF GREEN TO OFFER FOR AUCTION THREE MOBILE HOMES ACQUIRED AS PART OF THE MASSILLON ROAD/STEESE ROAD ROUNDABOUT PROJECT ("PROJECT"), AND DECLARING AN EMERGENCY.

WHEREAS, City Council authorized the sale of unneeded items on ebay by Resolution 2008-R37; and

WHEREAS, the City acquired three (3) mobile homes as part of the property acquisition for the Project; and

WHEREAS, the City desires to dispose of the mobile homes by public sale and/or auction because they are not needed for any municipal purposes; and

WHEREAS, each mobile home is valued at more than One Thousand Dollars (\$1,000.00).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

SECTION ONE:

City Council authorizes and directs the public sale and/or auction of three mobile homes purchased as part of the property acquisition for the Massillon Road/Steeze Road Roundabout Project to progress towards completion.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
