AN ORDINANCE TO ESTABLISH COMPENSATION FOR MEMBERS OF THE CIVIL SERVICE COMMISSION AND APPOINTED MEMBERS OF THE DESIGN REVIEW BOARD, AND DECLARING AN EMERGENCY.

WHEREAS, members of the City's Board of Zoning Appeals are compensated for their work on that Board at the rate of One-Thousand Five Hundred Dollars (\$1,500.00) per year; and

WHEREAS, members of the City's Planning and Zoning Commission are compensated at the rate of One Thousand Five Hundred Dollars (\$1,500.00) per year; and

WHEREAS, members of the Civil Service Commission **and Appointed Members of the Design Review Board** devote a substantial numbers of hours each month fulfilling their duties as a member of that Commission **and Board**; and

WHEREAS, the City's Administration believes that it appropriate to provide compensation to members of the Civil Service Commission **and Appointed Members of the Design Review Board**; and

WHEREAS, the City's Administration believes that the rate of compensation for members of the Civil Service Commission **and Appointed Members of the Design Review Board** should be the same amount paid to the Board of Zoning Appeals and the Planning and Zoning Commission.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT AND STATE OF OHIO, THAT:

SECTION ONE:

City Council approves compensation to members of the Civil Service Commission **and Appointed Members of the Design Review Board** at the rate of One Thousand Five Hundred Dollars (\$1,500.00) per year.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it

shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
