**INTRODUCED: MARCH 27, 2007**

**A RESOLUTION HONORING FORMER COUNCILMAN JOE SHEEHAN'S SERVICE TO OUR COUNTRY AND CELEBRATING HIS RETURN FROM THE WAR IN IRAQ.**

WHEREAS, Joe Sheehan served honorably for eight years as the Ward Three representative on Green City Council from 1998 through 2005, becoming only the second person in the city's history to reach term limits; and

WHEREAS, Joe Sheehan enlisted with the United States Marine Corps in 1976 and was promoted to the rank of Colonel in August of 2006; and

WHEREAS, Colonel Sheehan is currently serving in his 14<sup>th</sup> year as a Marine Corps reservist after 13 years of active duty; and

WHEREAS, Colonel Sheehan was deployed to Fallujah, Iraq on August 15, 2006 to serve as a Liaison Officer for the Multi National Corps-Iraq C9 (Civil Military Operations) branch in Baghdad; and

WHEREAS, while in Iraq, Colonel Sheehan worked with contractors to restore infrastructure, engaged in briefings with Generals on contractor's plans and progress, assisted with telecommunications projects, and attended numerous city council meetings to give presentations on work being done and progress being made; and

WHEREAS, Colonel Joe Sheehan will be returning from the War in Iraq to his home in Green in March of 2007; and

Whereas, Green City Council recognizes the dedication and sacrifices made by Joe Sheehan and the hardship his family endured as a result of his absence at home, most especially his wife Kari and son Joseph.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:**

**SECTION ONE:**

Green City Council formally thanks Colonel Joe Sheehan for his service to our country, and honors his safe return from the War in Iraq. Council expresses a debt of gratitude for Colonel Sheehan's many years of service to the City of Green and the United States of America, and congratulates him for his selfless dedication.
