**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:**

**SECTION ONE:**

Green City Council, pursuant to §1244.05 of the Codified Ordinances of Green, confirms the dedication plat for Town Crossing, Phase II.


**SECTION TWO:**

**SECTION THREE:**


