A RESOLUTION MAKING AN APPROPRIATION FROM UNAPPROPRIATED FUNDS FOR FLOWER AND PLANT PURCHASES, AND DECLARING AN EMERGENCY.

WHEREAS, it is necessary to appropriate funds for the purchase of hanging flower baskets and the installation of planting beds located at Massillon Road and the Interstate 77 entrance/exit ramps.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the appropriation of Eight Thousand Eight Hundred Dollars (\$8,800.00) to the General Supplies account (248-6100-52512) from the unappropriated balance of the Beautification Fund for the purchase of hanging flower baskets and the installation of planting beds located at Massillon Road and the Interstate 77 entrance/exit ramps.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
