A RESOLUTION MODIFYING APPROPRIATIONS WITHIN THE CITY'S FLEXIBLE SPENDING ACCOUNT AND CERTAIN OTHER FUNDS IN ORDER TO PROVIDE SUFFICIENT FUNDING FOR EMPLOYEES ENROLLED IN THE FLEXIBLE SPENDING ACCOUNT PLAN AND OTHER DEFICIENT ACCOUNTS, AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to the general laws of the State of Ohio, it is necessary to cover all obligations certified from or against an appropriation; and

WHEREAS, the City of Green budget requires a modification of appropriations in order to provide sufficient funds.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, STATE OF OHIO, THAT:

SECTION ONE:


Green City Council authorizes the modification of appropriations for the General Fund and all other funds for the City of Green, as contained in **AMENDED** Exhibit "A" (attached).

SECTION TWO:


The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and any deliberations of this Council and any of its committees that resulted in those formal action were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise, it shall take effect and be in force at the earliest time allowed by law.
