**A RESOLUTION APPROPRIATING FUNDS FOR FREEDOM FEST, A CELEBRATION OF THE CITY OF GREEN'S FIFTEENTH ANNIVERSARY, AND DECLARING AN EMERGENCY.**

WHEREAS, the City of Green will celebrate its fifteenth anniversary in 2007; and

WHEREAS, the City has scheduled a celebration event on June 30, 2007 titled "Freedom Fest"; and

WHEREAS, it is necessary to appropriate funds to pay for the entertainment that will be provided during Freedom Fest including a performance by the Akron Symphony Orchestra, a car show, magic show, musical entertainment and fireworks; and

WHEREAS, it is necessary to appropriate funds to pay for various rides, games and attractions; and

WHEREAS, it is necessary to appropriate funds to provide for food and refreshments; and

WHEREAS, it is necessary to appropriate these funds to properly celebrate Green's fifteenth year as a city.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:**

**SECTION ONE:**

City Council authorizes the appropriation of Fifty Thousand (\$50,000.00) Dollars from the Parks and Recreation Fund to the Community Event Program Account (224-6000-52513).

**SECTION TWO:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

**SECTION THREE:**

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and
