**A RESOLUTION AUTHORIZING THE CITY OF GREEN TO PREPARE AND SUBMIT APPLICATIONS TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT PROGRAM AND THE LOCAL TRANSPORTATION IMPROVEMENT PROGRAM FOR THE STEESE ROAD RECONSTRUCTION PROJECT, AND DECLARING AN EMERGENCY.**

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure; and

WHEREAS, the City of Green is planning to make capital improvements to Steese Road, and the intersection of Steese and Shriver Roads; and

WHEREAS, the Steese Road and the Steese Road/Shriver Road intersection infrastructure improvements are considered a priority for the community and is a qualified project under the Ohio Public Works Program.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:**

**SECTION ONE:**

City Council authorizes the City of Green to apply to the Ohio Public Works Commission for funding.

**SECTION TWO:**

The Mayor of the City of Green is further authorized to enter into any agreements necessary and appropriate for obtaining this financial assistance.

**SECTION THREE:**

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting of this Council and any deliberations of this City and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

**SECTION THREE:**

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety, and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
