A RESOLUTION MAKING AN APPROPRIATION TO SUPPORT THE CHRISTMAS POPS PERFORMANCE BY THE AKRON SYMPHONY ORCHESTRA IN THE CITY OF GREEN, AND DECLARING AN EMERGENCY.

WHEREAS, the Akron Symphony Orchestra performed at the City of Green's fifteenth anniversary celebration; and

WHEREAS, the symphony's performance in June, 2007 was hugely successful and the City has received many requests for a repeat performance by the symphony in the City; and

WHEREAS, the Akron Symphony Orchestra is willing and able to present a Christmas Pops performance in the City of Green at The Chapel on December 19, 2007; and

WHEREAS, it is necessary to appropriate funds to pay for the symphony's performance.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

City Council authorizes the appropriation of Seventeen Thousand Dollars (\$17,000.00) to the Christmas Pops-Akron Symphony Account (224-6000-52514) from the unappropriated balance of the Parks and Recreation Fund.

SECTION TWO:

The City of Green finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council and any deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

SECTION THREE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
