**CITY OF GREEN MUNICIPAL INCOME TAX  
EFFECTIVE AUGUST 1, 1992**

The City Council passed Ordinance No. 92-11 effective August 1, 1992, enacting a one percent (1%) income tax. **(Citizens voted to increase the income tax to (2%) two percent effective January 1, 2004).** The municipal income tax is required to be paid by all persons eighteen years of age or older employed within the City of Green, and by all residents of the City of Green eighteen years of age or older working outside the city. A credit of up to two percent (2%) will be allowed for taxes paid by residents of Green to another municipality. The tax also applies to net profits of corporations, partnerships, and businesses within the City of Green.

The following forms of income are taxable: earned income (salaries, wages, commissions including wage continuation plans for sick pay, vacations, etc.) tips, distributive share of net profits of a partnership or subchapter "S" corporation which is not taxed as an entity in Green, net profits from a business, net rental income, gas & oil royalties, and income from lotteries which is subject to taxation by IRS.

The following items of income are **not** taxable: pensions (both public & private), annuities, interest income, capital gains on investments and other unearned income including alimony and child support, proceeds from insurance, welfare, unemployment benefit payments paid by the State of Ohio. Also exempt is military pay and allowances for active duty with the armed forces.

**REGISTRATION**

All residents receiving this notice are required to complete the enclosed registration and return it to the Income Tax Office within ten (10) days.
