A RESOLUTION AWARDING A CONTRACT TO H.M. MILLER FOR THE EAST LIBERTY GREEN SANITARY TRUNK EXTENSION, PHASE II PROJECT ("PROJECT"), PER SPECIFICATIONS, AND DECLARING AN EMERGENCY.

WHEREAS, the City advertised a "Notice to Bidders" in the Akron Beacon Journal on December 1, 2006 and December 8, 2006; and

WHEREAS, on Wednesday, December 20, 2006 at 10:00 a.m. the City Engineer received and opened sealed bids for the Project; and

WHEREAS, the City Engineer has reviewed the bids and recommends that the contract be awarded to H.M. Miller Construction for the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

SECTION THREE:

The Mayor is authorized and directed to enter into an agreement between the City of Green and H.M. Miller Construction for the Project.

SECTION FOUR:

The Finance Director of the City of Green is authorized to make payment to H.M. Miller Construction for the Project through the established purchase order procedure.


SECTION FIVE:






