A RESOLUTION AWARDING A CONTRACT TO EARTH 'N WOOD PRODUCTS FOR TOPSOIL MATERIAL, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Green advertised a "Notice to Bidders" in the Akron Beacon Journal on January 22, 2007 and January 29, 2007; and

WHEREAS, on Monday, February 5, 2007 at 10:00 a.m. the Service Director received and opened sealed bids for topsoil material; and

WHEREAS, the Service Director has reviewed the bids and recommends that a contract be awarded to Earth 'N Wood Products for the purchase of topsoil material.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:


SECTION FOUR:

SECTION FIVE:

Council declares this to be an emergency immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of Green. Provided that this legislation receives the affirmative vote of three-fourths of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest time allowed by law.
