A RESOLUTION AUTHORIZING THE CITY OF GREEN TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION ("OPWC") STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED FOR THE WISE ROAD CULVERT PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure; and

WHEREAS, the City of Green is planning to make capital improvements to reconstruct the Wise Road Culvert; and

WHEREAS, this infrastructure improvement is considered a priority need for the City of Green and is a qualified project under the OPWC programs.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GREEN, COUNTY OF SUMMIT, AND STATE OF OHIO THAT:

SECTION ONE:

Green City Council authorizes the Planning Director to apply to the OPWC for funds for the Wise Road Culvert Project.

SECTION TWO:

Green City Council also authorizes the Mayor to enter into any agreements as may be necessary and appropriate to obtain this financial assistance.
